**ORDER**

Whereas under section 149(2) © & (3) of the H.P. Municipal Act 1994 no person shall throw any type of garbage /refuse etc. on public place road street or in open hill side except in a container provided by the Municipality for this purpose. Whoever contravenes the provision of sub-Sec.(2) shall be punishable with fine which may extend to five hundred rupees, in addition to other charges incurred for cleaning or removal of such garbaged refuse etc. from such public place ,street or in open hill side by the Municipality.

Whereas it is mandatory to collect the garbage /refuse etc. at the door step of household by the garbage collector engaged by the Municipal Council and also ordered by the National Green Tribunal to make this process compulsory in every town.

Therefore I Urvashi walia Executive Officer Municipal Council,Theog in exercise of power vested in me under section 66 of Municipal Act,1994 hereby declare the following “User charges “ for collection of garbage /refuse etc. from the door step of respective buildings.
