Terms and Conditions for the allotment of space for temporary stalls etc at Nehru Ground on dated 11-08-2026 through Open auction: -

1. The Contract shall be awarded to the highest bidder. The minimum bid for the allotment of above space/Nehru Ground shall be ₹ 9996000 lac. (Rupees Ninty nine lac ninty six thousand rupees) the bid below this amount shall not be entertained. Any taxes as applicable under rule/law shall be paid by the successful bidder at his own label.
 2. That the Contract shall remain in force w.e.f 20-08-2026 to 13-09-2026 (Two Days extra given for removing of german hanger temporary shops etc and no commercial activity will be allowed during this period) i.e till 15-09-2026. In case of Force Majeure event 3 days extra i.e upto 18.09.2026 will be given extra to the highest bidder. The ground will be handed to bidder on 17th afternoon for setting up of shops/stalls and dome.
 3. Deposit of earnest Money of ₹ 30 Lac (Thirty Lac) till 11:30 AM on dated 11/08/2026 in favor of undersigned in form of D.D.(Demand Draft)/NEFT/RTGS and application form cost @ 10000/- is mandatory to take part in the auction i.e. can be issued on dated 11/08/2026 upto 11:30 AM and pay participate in bid through email.
 4. Two-year Experience certificate from recognized organization (Govt./ Semi Govt.) to organize international, National, state level, Distt Level fairs & Festival, One crore annual turnover, GST, PAN.
 5. Highest bidder will have to provide german hanger for audience during culture event of 15th and 16th august 2026 in the final bid amount; free of cost.
 6. Participants have to mention type of business/activities to be done on the above said place and such business /activities shall not be in contravention of any law or otherwise illegal in any manner and in case of change of his/her business he/she shall take prior permission of the undersigned.
 7. The highest bidder has to deposit 25% amount of the bid through D.D in favour of the Executive Officer Municipal Council, Theog immediately after the acceptance of highest bid /award of contract and 25% amount till 22/08/2026 after award of contract and remaining amount deposit upto 08/09/2026.
 8. The allottee under any circumstances shall not be allowed to indulge into any kind of criminal Activities, gambling etc. in the allotted premises and shall not use the shop and its surrounding area for following works and sale:
 - i. Workshop or any business which required electrical motor more than 1 HP Capacity.
 - ii. Any kind of explosive articles including crackers etc.
 - iii. Sale and storage of objectionable, prohibited and injurious articles.
 - iv. Sale and storage of explosive and injurious chemicals.
 - v. Any articles generating bad odor and creating environmental pollution.
 - vi. Any kind of heavy machineries etc. which may cause any danger to premises/ building.
 - vii. To display or exhibit pictures, posters statues or other articles which are repugnant to the morale or are of indecent, immoral or other improper character.
 - viii. To display or exhibit any advertisement or placard or put up a hoarding part of the interior or exterior other than those permitted expressly in writing by Executive Officer Municipal Council Theog
 - ix. To keep any animals or conveyances in or outside the shop/premises.
 - x. Any food stall shall be inspected by food inspector randomly to collect
 9. The allottee shall not carry out any illegal activities, anti-social activities, anti national activities etc. in the premises.
 10. The allottee shall strictly adhere to all the directions/SOPs issued by the government of HP with regard to any prevalent health concern.
 11. The allottee shall be responsible to obtain necessary license, permit or permission required as per law to run the business of such nature and also to pay by himself/herself only any kind of Government /Municipal tax and other tax etc. applicable/leviable to run the business. The allottee shall have to obtain all required statutory and legal permission at his own level and at own cost, if necessary to run the activities. The Chairman Rehlee Mela committee cum Sub-Divisional officer/undersigned shall not be responsible for any such lapse on the part of the allottee.
 12. The Sub-Divisional Officer (C) Theog -cum- Chairman Rehlee Mela Committee or undersigned, reserves the right to reject any or all the Tenders/Quotations without assigning any reason. No enquiry verbal or written shall be entertained in respect of acceptance/ rejection of the quotation.
 13. The application form will be issued to those who will produce/Submitt valid experience certificate as well as fulfill other codal formalities for the purpose.
 14. Setting up of temporary Mela Shops (rain proof/water proof and fire proof).
 15. All disputes shall be settled within the jurisdiction of Court at Theog Town only
